6	How many Pensioner?	Currently there is no pensioner.
7	Does CPPA requires to maintain Pensioner data in HR?	No.
8	Does CPPA requires to maintain Pensioner data in Payroll for pension Payments?	No.
9	What are the prospects of having Phase wise distribution of implementation?	Being a public sector organization and as per best implementation practices, a phases wise approach is proposed. However any other suggestion can be discussed.
10	Joint ventures are permitted under the RFP. What are the documentation & legal requirements for JVs?	No.
11	What are the current Legacy systems?	Customize GL application, NTDC based customize HRIS, customize payroll, Smart metering System.

19	Training Strategy is part of the project Scope/WBS and is built after discussion amongst all parties. Is this required alongside the proposal>	A High level strategy.
20	Please specify how many legal entities/Chart of Accounts will be used	One Legal Entity, one Chart of Account.
21	Does CPPA have an existing data center? What are the data center locations and how is the existing solution running in various data Centers?	No existing Data Centre.
22	What is the specification of Hardware/servers and networking equipment running in existing data centers? Please share the equipment list if possible	Not available.
