An interactive and secure HTTPS based web portal is required to disseminate and receive the data and information within CPPA-G departments and external stakeholders like Ministry, Power Producers, DISCOs, NPCC, NTDC, and NEPRA etc. There are 10 DISCOs and 100+ IPPs.
2	What data formats are supported by corresponding systems from external agencies, named above for information extraction?	Examples are mentioned in clause 6.2.3 of RFP. However the SOP document as mentioned in RFP provides some formats for understanding. Please refer to SOP document.
3	What data formats are expected to be supported by Web Portal for providing data to external agencies, such as CPPA-G?	Examples are mentioned in clause 6.2.3 of RFP. However the SOP document as mentioned in RFP provides some formats for understanding. Please refer to SOP document.
4	What are the prevailing formats of CPPA-G for evaluation purposes under scope?	Bidder requested for the detailed meeting for the same.

5	At what frequency rate, the data is required to be synchronized (i.e. pulled & pushed)?	Data needs to be pushed/pulled periodically or as per requirement of business process.
6	What method of integration & format(s) are supported by Metering System of NTDC for CDP wise Meter Reading data?	Standard supportive formats of ERP systems such as .csv, .xlx etc. However server to server communication is required where applicable.
7	What is/are the process of generating MANUAL reports (i.e. to be automated)?	As per RFP, 50 customized reports are required.
8	What is the data volume for consideration of conversation into digital form from hard copy?	Most of the data is in the soft form, however if there is any requirement of Data Conversion during the course of project it will be required as per the relevant clause of RFP
